

ANTIOCH TOWNSHIP ASSESSMENT ROLL FOR 2024

OFFICIAL ASSESSMENT LIST:

This publication is the official notice to property owners of the 2024 assessments value changes in the Township of Antioch. These 2024 assessments, as published, are those determined by the Assessor and/or the Chief County Assessment Office.

The assessment roll recording the values of property determines only the distribution of the total tax burden among the individual property owners in Lake County. The Township Assessor and/or the Chief County Assessment Office have no control over the amount of taxes levied, nor the public expenditures. The amount of these assessed values (subject to State equalization), minus applicable homestead exemptions, multiplied by the established tax rate, determines the amount of your property tax bill.

EQUALIZATION

The following printed assessments, as well as all other assessments in the township, other than farm land and coal, are required by law to be assessed at 33.33% of market value, having been equalized to that level by the Chief County Assessment Office, who has applied a factor of 1.1168 to all values except those assessed under the provisions of Chapter 35 (ILCS), Act 200, Secs. 10-110 through 10-140, 10-145, 10-155, and 10-170 through 10-200. Application of the township equalization factor represents an 11.68% increase in the original assessments.

To determine the fair cash value of your property based upon the sales transactions in 2021 – 2023, divide the total assessed value by 0.3333. If it appears that the resulting number is higher than the market value of the property, you may be over-assessed. If the resulting number is less than market value, the assessment may be under-assessed.

ARRANGEMENT OF LIST

Your property is listed under the name of your city or village, which will be in alphabetical order. Each street within the city or village is also arranged in alphabetical order. Property on the same street will be listed beginning with vacant or improved property that has no street number, followed by property with street numbers listed in numerical

order. Note that the value that appears is a total assessed value for the property. All values are subject to a State equalization factor certified to the County Clerk by the Illinois Department of Revenue.

INFORMATION ON ASSESSMENTS

Questions regarding this assessment information should first be directed to the Antioch Township Assessor's office at 1490 Main St., Antioch, IL 60002. Antioch Assessor office hours are Monday – Friday 8:30 a.m. – 4:30 p.m. Any property owner who objects to the amount of their assessment should file an appeal, in writing, with the Board of Review on or before **October 15, 2024**. **Appeals must be filed electronically using the Board of Review's Smartfile E-filing portal at boardofreview.lakecountyil.gov. If you have questions on the E-filing process you can call the Board of Review office at 847-377-2100 or come to the Board office for assistance at 18 North County Street - 7th Floor, Waukegan, IL 60085-4335.** The Board of Review rules of procedure are also available on the internet at boardofreview.lakecountyil.gov. **Taxpayers have 30 days from the date of this publication to file an assessment appeal with the Board of Review.**

HOMESTEAD EXEMPTIONS

All owner-occupied properties may be eligible for one of the following homestead exemptions: General Homestead Exemption, Senior Homestead Exemption, Low-Income Senior Citizen's Assessment Freeze Homestead Exemption, Homestead Improvement Exemption, Homestead Exemption for Persons with Disabilities, Returning Veteran's Homestead Exemption or the Disabled Veteran's Exemption or the Standard Homestead Exemption for Veterans with Disabilities. Homestead exemptions reduce the assessment value for tax billing purposes. More information on homestead exemptions appears on the Chief County Assessment Office website.
